WHY HAVE I RECEIVED THIS BILL?

Redditch BID is a business-led, business-funded partnership made up of more than 350 members, all working together to enhance Redditch as a place to live, work, study, and enjoy leisure time. Funded by a levy on businesses with a rateable value of £5,000 or more, the BID generates and reinvests around £250,000 each year into the town centre through projects, campaigns, and initiatives outlined in our 2024–2029 business plan.

The BID provides added value rather than replacing local authority services, offering extra resources and activities that support both businesses and the wider community. The 'Yes' vote in the 2024 gave us the mandate to continue our work through to 2029.

THE BID LEVY

The cost of the levy for each business is a percentage of its rateable value and so is based on the size and location of the business premises. All businesses should consider the proposed cost of the levy as an investment – an investment of a relatively small sum which is pooled with the contributions of all the others in the BID to provide a considerable sum that is spent entirely in Redditch town centre.


The levy is 2% of the rateable value, meaning that the BID would only cost your businesses the following amount per year:

Rateable Value	Cost Per Year	Cost Per Week
£7,500	£150	£2.88
£25,000	£500	£9.62
£75,000	£1,500	£28.85

A 10% discount will be applied for tenants of Kingfisher Redditch to reflect the fact that they already pay a service charge.
